

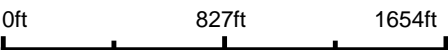
1. The parcels shall be offered for sale on **written and oral** bids.

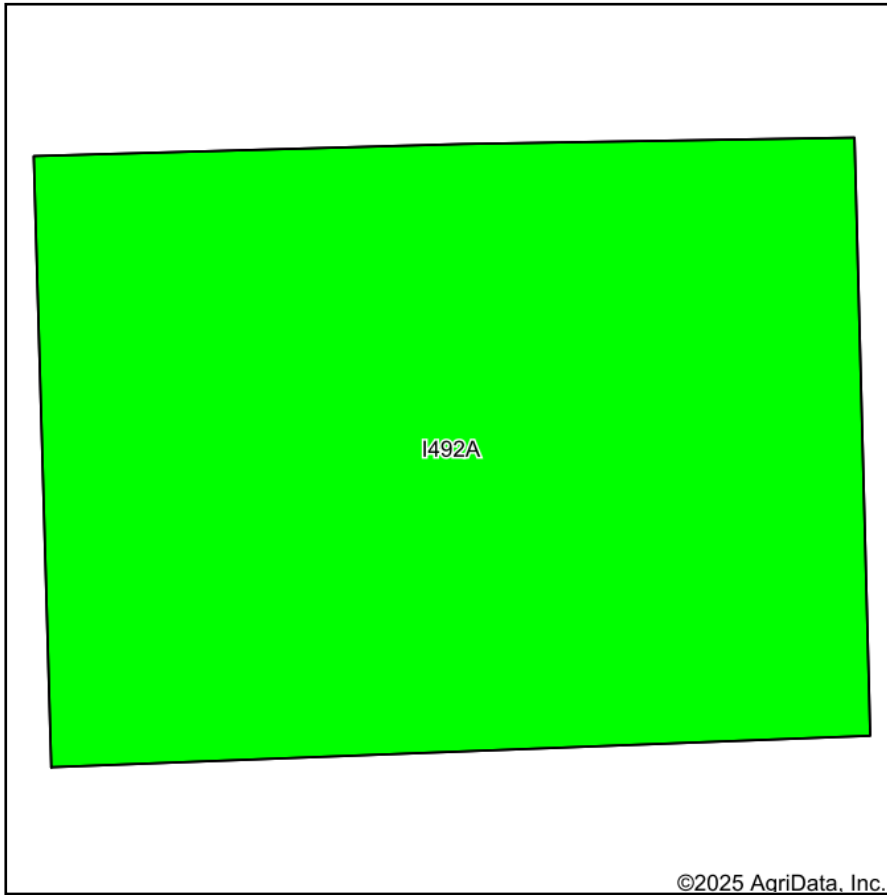

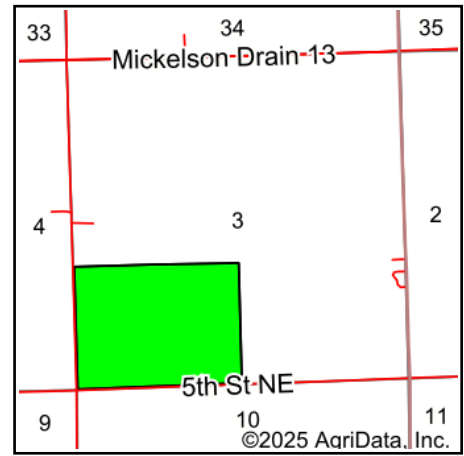
